

Photo Waiver

I am aware that pictures/videos of my child may be taken at the West Valley Youth Football and Cheer events during the West Valley Youth Football and Cheer season. I am aware that pictures/videos may be posted to the website and/or social media. The pictures/videos will be used for the purpose of illustrating the activities during the football/cheer season. Pictures/videos posted on the website and/or social media are considered property of West Valley Rebels Youth Football and Cheer Association and may not be sold or reused without the consent of West Valley Rebels Youth Football and Cheer Association. Parents who have special concerns or requirements regarding photography of their child/children agree to contact West Valley Youth Football and Cheer Association in advance of the 2019 season to resolve and issue regarding the use of their child's photographs.

Payments

1. A \$100 deposit is required. The remaining balance may be split into 3 payments. Payment in full is due by July 1st. All credit card transactions are subject to a 2% fee and all payments are non-refundable. A non-dated refundable equipment deposit check for \$200.00 (given back when equipment is returned at end of season)

Parent/Guardian Code of Conduct

All parents/guardians who have children participating at West Valley Youth Football and Cheer Association must abide by a Code of Conduct,

which includes the provisions that follow. Any violations of these rules may result in the revocation of privileges at West Valley.

2. To furnish the necessary documents for player certification. **This includes a completed application, a current physical (chiropractor physicals will not be accepted), participant's end of the year report card, a copy of participant's birth certificate as well as the original for certification before certification.**
3. To be financially responsible for West Valley's equipment issued to the player including reimbursement for the loss, damage or neglect to returned equipment to West Valley.
4. No smoking on the practice field or playing field or in the presence of any children on school property.
5. To abstain from the possession and drinking of alcoholic beverages on school property or any West Valley functions. This includes practices, games or events.
6. Not to incite, belittle, antagonize, berate or participate in any unsportsmanlike behavior against a player, parent or board member of West Valley, the opposing team, coaches, players, fans, officials/judges at any West Valley or Pop Warner function.
7. Not to use any abusive or profane language at any time while at a West Valley or Pop Warner function.
8. To accept all decisions of the game officials, West Valley board members or Pop Warner officials as being fair and called to the best of their ability.
9. To follow the proper chain of command when filing a complaint at West Valley:
Chain of Command as followed;
A. Head Coach
B. Football/Cheer Director
C. President

10. To take responsibility for any actions violating the Code of Conduct by any guest or relative of an attending parent or guardian.
11. To fully abide by all rules set forth above and understand it is our duty as a parent/guardian to set an example of good sportsmanship to our children.
12. Spectator or player parents are not authorized during the commencement of any scrimmage, practice, game or other events unless authorized by the President of West Valley.

I/We acknowledge that failure to comply with these guidelines may result in immediate and permanent suspension from the West Valley Rebels organization. Pursuant to West Valley Youth Football and Cheer Bylaws ARTICLE 4: MEMBERSHIP, SECTION 3, Suspension or Termination: "Executive Board Members shall have the authority to discipline, eject, or suspend the membership of any member immediately when the conduct of such person is considered detrimental to the best interest of the players and the organization."
